- Health Status: Please reschedule if you have a cold sore, rash, or active illness on the day of treatment.

#### Post-Treatment Instructions

- · Avoid Touching or Massaging: Do not rub, massage, or apply pressure to the treated area for at least 24 hours to avoid unintended spread of the neurotoxin.
