

#### **Pre-Treatment Instructions**

- Avoid Blood Thinners: Discontinue aspirin, ibuprofen, fish oil, and other blood-thinning supplements at least 7 days before your appointment to reduce bruising.
- Avoid Alcohol and Smoking: Refrain from alcohol and smoking for 24 hours prior.
- Skincare Precautions: Avoid Retin-A or other potent skincare treatments for 2 days before and
- Eat and Hydrate: To minimize the chance of lightheadedness, please ensure you've eaten and are hydrated prior to the procedure.
- Health Status: Reschedule if you have a cold sore, rash, or active illness on the day of treatment.

#### Post-Treatment Instructions

- Avoid Exercise and Heat: Avoid strenuous exercise, saunas, and hot tubs for at least 24 hours to help the neurotoxin settle in the intended area.
- Stay Upright: Refrain from lying flat or applying pressure to the treated areas for 4 hours post-
- Avoid Makeup: Do not apply makeup or skincare products to the treated areas for 24 hours.
- Dietary Precautions: Limit alcohol, caffeine, high-sodium and sugary foods, and cigarettes for 24-48 hours after treatment to minimize swelling







## **Expected Results and Limitations**

- Rapid Onset: Dysport typically begins working within 2-3 days, with full results at 1 week.
- Temporary Results: Effects usually last 3-4 months, depending on individual factors; maintenance treatments are recommended for prolonged benefits.

- · Allergic Reactions: While rare, severe allergic reactions are possible; immediate medical attention should be sought if symptoms such as itching, rash, or swelling occur.

Dysport treatment is not recommended for those who:

- Have allergies to botulinum toxin or any Dysport ingredients.
- Have neuromuscular conditions like myasthenia gravis or Lambert-Eaton syndrome.
- Have active skin infections or inflammation at the treatment site.
