Procedural Description

HydraFacial Keravive deeply cleanses, exfoliates, and hydrates the scalp and hair follicles while delivering powerful antioxidants and vitamins to the skin's surface. The treatment removes dirt, oil, flakes, dead skin cells, and impurities from the surface of the scalp and from hair follicles and stimulates scalp circulation. This treatment includes one home care bottle of HydraFacial Keravive Peptide Complex Spray. The HydraFacial Keravive works well for anyone suffering from changes in their normal hair growth patterns, regardless of hair type, texture, or length. It's also an excellent option to keep your scalp healthy. Some patients who experience dry scalp, itchiness, seborrheic dermatitis, dandruff, or other scalp conditions, including irritations, find regular treatments beneficial.

If you find that routine shampooing doesn't leave your hair and scalp feeling as clean as they should, the HydraFacial Keravive is an excellent adjunct treatment to remove any buildup. And it's a great option for a deep-down scalp cleanse, which regular shampooing doesn't provide to the same degree. Although frequent washing is a must for all hair types-thinning hair or not-the scalp's pores, like those on the face, can become clogged and lead to breakouts, redness, inflammation, and slowed growth. But removing pore-clogging debris and exfoliating the scalp allows it to function optimally and healthily.

This relaxing scalp health treatment is an ideal prepping treatment to use in combination with other hair restoration services such as scalp Microneedling and injections of PRR or exosomes. A threemonth protocol offers a healthier scalp and continued hair growth if used in combination with takehome Nurtafol hair growth supplements and topical Peptide Complex Spray. Ideal for anybody looking to promote scalp health and hair growth, this innovative treatment is performed by our team of medical aestheticians and registered nurses.

Before Your Treatment

- Arrive at your appointment with clean, dry hair without any styling products.
- · Most patients plan their treatment around important events, as the hair may have a slight sheen to it immediately after treatment because of the serum application.
- Do not use aggressive exfoliation, micro-needling, scrubs, etc. one week prior to treatment and one week post-treatment.

What to Expect During the Treatment

Step 1 (In-Office): Cleanse & Exfoliate with HydraFacial Vortex Technology extracting dirt, oil, and impurities from the scalp and hair follicles while stimulating circulation.

Step 2 (In-Office): Stimulate & Nourish using HydraFacial Keravive Peptide Complex Solution nourishing and stimulating the scalp and hair follicles with growth factors and skin proteins to promote thicker, healthier-looking hair.

Step 3 (At-Home): Extend & Enhance Daily use of the special Peptide Complex Spray enhancing the in-office treatment and delivering daily stimulation and nourishment to the scalp and hair follicles.

Post-Treatment Instructions

- · Your scalp may experience temporary irritation, tightness, or redness. These are all normal reactions that typically resolve within 72 hours depending on scalp sensitivity.
- · You may experience tingling and stinging in the treatment area. These sensations generally subside within a few hours.
- · Client experiences may vary. Some clients may experience a delayed onset of symptoms.
- · The combination of in-office cleansing, exfoliation, hydration, and daily use of the take-home spray improves circulation and nourishes the hair follicles for thicker, shinier, healthier-looking
- · After your treatment is complete, your provider will demonstrate how and where to use the takehome Peptide Complex Spray to continue nourishing your refreshed scalp. For best results, we recommend waiting at least 6-12 hours before washing your hair after Hydrafacial Keravive treatment.
- · Immediately after treatment please allow the scalp and hair to dry before using heat or styling products.
- The day after your HydraFacial Keravive in-office treatment use the Keravive 30-Day Peptide Complex Scalp Spray once a day for 30 days. Use the nozzle to directly spray 1-2 pumps on the scalp in each problem area and vigorously massage it for 30-60 seconds.
- · For best results apply in the evening to allow the solution to remain on the scalp overnight.
- The scalp can be susceptible to sunburn/ sun damage. Avoid excessive sun exposure and use a minimum of SPF 30 sunscreen.
- It is recommended to have the HydraFacial Keravive in-office treatment once a month for 3 consecutive months with continuous daily use of the take-home spray throughout.

The nature of the Hydrafacial Keravive procedure has been explained to me. I understand that just as there may be benefits from the procedure, all procedures involve risk to some degree. Side effects may include, irritation, tightness, redness on the scalp, stinging or tingling, allergic reactions, dissatisfaction with results, need for further procedures, & unforeseen side effects may occur. I understand that the following are among the expected side effects of the Hydrafacial Keravive procedure:

Temporary irritation, tightness, or redness:

If these reactions are ongoing, discontinue the use of the take-home spray until they are resolved (typically resolve within 72 hours depending on scalp sensitivity).



Slight Tingling:

You may experience slight tingling and/or stinging in the treatment area. These sensations generally subside within a few hours.

Delayed Onset:

Client experiences may vary. Some clients may experience a delayed onset of symptoms.

Sunburn/sun damage:

The scalp can be susceptible to sunburn/sun damage. Always avoid excessive sun exposure. We recommend using a minimum of SPF 40+ sunscreen, protective clothing, and accessories when exposed to the sun.

Pregnancy:

This treatment has not been studied in pregnant or nursing women so it is not recommended.

I acknowledge the following has been discussed with me:

- I understand the Risks / Complications / Side effects / Consequences of Scalp Treatments to the Skin: allergic reactions, swelling, itching, infection/lack of permanent results or unsatisfactory results, need for further procedures.
- I will avoid the use of aggressive exfoliation, waxing, and products containing glycolic acids or retinols that are not part of the recommended take-home regimen in the treated areas for a minimum of 2 weeks pre-and post-treatment.
- Photos may be taken before, during, and after the HydraFacial treatment. Photos will only be used with my written approval for education, promotion, or advertising purposes.
