

YUMITM KERATIN LASH LIFT AND TINT AFTERCARE AND CONSENT FORM

Procedural Description

YUMI™ is a keratin lifting and tinting treatment that actually manipulates the natural keratin found inside the lashes, lifting it upwards into a beautiful curve. The lift begins at the root of the lash, completely showing off the full length of the lash. The lashes are then infused with a special pigmentation which further enhances the look by making the lashes appear thicker and darker.

This professional keratin treatment lifts, curls, and boosts your natural lashes instantly. You'll have thick, dark lashes that beautifully curve upwards creating the "open eye" look. Yumi Lashes is a luxurious alternative to eyelash extensions, fake eyelashes, growth serums, and mascara. This exclusive treatment is the best in the U.S. and is non-toxic, hypoallergenic, formaldehyde free, paraben free, cruelty-free, vegan, and will not harm your eyelashes or interfere with their natural growth. The treatment will take 90 minutes during which your eyes will be closed and you can relax. Your lash lift will last anywhere from 8-12 weeks, which is the natural life cycle of an eyelash. The tint will last up to 4 weeks and you can always get them re-tinted at the halfway mark to your 8-week lift. The lift is safe and healthy to get every 8 weeks.

Before Your Treatment

- · You are advised NOT to get your eyelashes wet for a full 48 hours after receiving your Yumi Lash Lift, so we recommend taking a shower before your appointment, so you can last the two days.
- Remove contact lenses before your treatment. We provide solutions and cases if needed.
- Come to your appointment without any eye makeup. In case you can't, we have make-up removers.
- · Avoid using waterproof mascara 2-3 days prior as it can leave a residue that may prevent lashes from lifting properly.
- · Avoid curling your natural lashes with a lash curler for 48 hours prior to your appointment.
- Ensure that you do not have an eye infection or irritation of the eye area as treatment cannot be performed until this has cleared up.
- · If you have had Lasik surgery, you must wait a minimum of 6 months from the time of your
- If you have extensions, removal is required prior.

What to Expect During Treatment

- YUMI™ processing solution is strictly applied to the lashes and carefully applied by a Yumi Master Expert minimizing the possibility of the solution coming into contact with the skin or inner eye area, limiting any possible irritation.
- The lashes are delicately wiped during the procedure, which may cause mild redness but will diminish within 10-15 minutes after completion.
- Once the treatment is completed, you may go about your normal activities.
- YUMI™ Lash Lift can last anywhere between 8 to 12 weeks.
- YUMI™ Lash Tint will last approximately 4 weeks.
- · When following proper lash lift after-care by not wetting the lashes for 48 hours, avoid any heavy oils, creams, wipes, and sleep eye masks-it will help the longevity of your lash lift.

Post-Treatment Instructions

- · Do not get your lashes wet for the first 48 hours. Showering within this period exposes your lashes to water, heat, and steam, relaxing the lift and weakening or undoing its results.
- · Avoid steam rooms, saunas, or direct contact with hot water in general.
- No mascara for the first 48 hours & avoid waterproof mascaras in general.
- Try to sleep on your back & keep your lashes off the pillow. Your lashes are prone to kinks during the first 48 hours after the procedure.
- Wait at least 6-8 weeks until your next lift & tint appointment.
- NO eyelash curlers as they may weaken and damage your lashes.
- Do not touch or rub your eyes & eyelashes immediately after the treatment.
- Be gentle with your lashes no rubbing or pulling.
- · Remove eye makeup gently with oil-free remover.
- Do not wet lashes for 48 hours after treatment, for optimum results.
- During the 48-hour period, please avoid:
 - Eye makeup on lashes
 - Oils
 - Creams
 - Makeup wipes
 - Micellar water
 - Steam rooms
 - Swimming
 - Tears
 - Sleep eye masks
 - o or anything that will moisten the lashes, weigh them down and weaken the lift.
- Keep lashes untangled, by brushing with eyelash spoolie (brush).
- Gently brush your lashes UPWARDS as needed with a spoolie.
- Use YUMI™ Keratin Lash Treatment Mascara for nourishment and aftercare.

YUMI™ Lash Lift and Tint Consent Form:

The nature of the YUMI™ Lash Lift and Tint treatment has been explained to me. I understand that just as there may be benefits from the treatment, all treatments involve risk to some degree. I understand that the following are among the expected side effects of the YUMI™ Lash Lift and Tint treatment:

Redness/Eye Irritation:

Tinting/lifting lashes could have some inherent risk of irritation to the orbital eye area, including the eye itself, and could result in stinging or burning, blurry vision, and potential blindness should any of the solutions enter into the eye area.

Over Processed Lashes:

There is a chance of under-curling, over-curling, or damage to the natural lashes.

Unsatisfactory Results:

Lashes can have a growth pattern such as that of a cowlick, natural curl, or slanted. This can cause the lashes to grow in different directions. Although every effort is made to tame or straighten the lashes there is no guarantee the lashes will be perfectly straight as they can take on their own form again.

Allergic Reactions:

Even though my technician perms the lashes using the proper technique, cleaners, eye gel pads, adhesives, and removers used may irritate or cause an allergic reaction.

I acknowledge the following has been discussed with me:

- I understand the Risks / Complications / Side effects / Consequences associated with having an eyelash lift/or eyelash tint. I further understand that as part of the procedure, eye irritation, eye pain, eye itching, discomfort, and in rare cases, eye infection or blurriness could occur. I agree that if I experience any of these medical conditions with my lashes then I will contact my therapist and consult a doctor at my own expense.
- I understand that even though my provider lifts the lashes using the proper technique, the instruments, tapes, cleaners, eye gel pads, adhesives, and removers used may irritate my eyes or require a doctor's follow-up care.
- I understand and agree to the care instructions provided by my provider for the use and care of my permed and/or limited eyelashes. I realize and accept the consequences of failure to adhere to these instructions may cause the eyelashes to not stay permed as long as told.
- Financial Responsibilities This procedure is elective and not medically necessary and therefore, not covered by insurance. Any complications requiring additional medical care and/or treatment or revisionary procedures would be the patient's responsibility also. There are no refunds.
